
My name is Heather Bendure. I have lived in Grosse Pointe Park for almost 30 years and currently reside on Beaconsfield.

I met Vikas under unfortunate circumstances when both of our basements fell victims to the sewage backup incident of 2016. From that event and after, I have only known Vikas to be a compassionate, spirited and proactive neighbor. I am grateful for his leadership.

While I am not a regular attendee or commenter at Council meetings, as a former civil rights attorney, I feel compelled to comment on this issue. I urge the Ethics Review Board to dismiss the complaints against Vikas.

Section 2-4 of the ethics code explains that the code "is intended to be preventative and not punitive" AND that it "should not be construed to interfere with or abrogate in any way the provisions of any federal or state statutes..." Complainants' requested relief both defies the stated purpose of the code and has constitutional implications. Sanctioning an elected official's (even distasteful) comments on controversial issues addressed in the community and printed by local press sets a dangerous precedent. It is no secret that Vikas is now the sole dissenting voice on Council. Discourse is an important and healthy part of any democratic government. The Complainants' attempts to silent (or temper) a minority voice should not succeed.

Given the stated purpose of the Code under which the Complainants seek relief and the chilling effect sanctions would have on elected officials' speech, the Complaints should be dismissed.
